

# Government Incompetence is Killing Us

Federal & State Governments All Fail To Warn Public about Low Vitamin D

The cost of this civic incompetence, in the context of covid-19 response, has been avoidable death, sickness, massive transfer of wealth, upwards [1] and economic destruction, especially of small businesses. These will have further reverberations in disaster capitalism style looting (see: *The Shock Doctrine: The Rise of Disaster Capitalism*, by Naomi Klein), decayed mental and physical health of the populace, an enlargement of a permanent underclass, despair, and possible loss of civil rights. The United States is on a trajectory of becoming a 3rd world nation.


I also accuse each and every state government of similar civic incompetence.

I have looked at the covid-19 sections of each and every state web site - from Alabama's to Wyoming's - and found **not a single one** recommended getting Vitamin D levels checked. Apparently, NO state government - whether dominated by Republicans, or Democrats, or neither - demonstrated enough competence to have acted expeditiously on behalf of their citizens.

## covid-19 and Vitamin D

A growing body of evidence has been coming in about Vitamin D sufficiency and covid-19 mortality.

The data out of Indonesia may be the most stunning. As reported in SSRN, *Patterns of COVID-19 Mortality and Vitamin D: An Indonesian Study*, which compared the death rates of hospitalized covid-19 patients with respect to their vitamin D blood levels:



Mortality	Vitamin D Status	Vitamin D Blood Level
98.9% died	deficient	< 50 nmol/L
87.8% died	insufficient	50-75 nmol/L
4.1% died	normal	> 75 nmol/L

## Federal government is as incompetent as the States

Looking at the CDC.gov's "Prevent Getting Sick" page in their covid-19 section, we again find nothing about Vitamin D. Given the dire nature of the covid-19 threat, we can expect that, even if vitamin D insufficiency was known to be uncommon, in a civically competent state, a public education campaign to spare a small, vulnerable sub-population would nevertheless have been conducted. As it turns out, there was a crying need for ongoing public education campaigns long before 2020, since it was known that vitamin D insufficiency is widespread. While the incidence of Vitamin D deficiency is generally enormous, it is catastrophically so in African-Americans, and other darker-skinned Americans. In fact, rickets is on the rise! Another risk factor for vitamin D deficiency is age, because we become less efficient at creating vitamin D via sunlight exposure, as we age. The Federal government has equally failed to protect the elderly.

## Vitamin D vs. disease

There is an impressive list of diseases and conditions for which evidence exists correlating adequate vitamin D levels with lower susceptibility. This includes: breast cancer, colorectal cancer, diabetes, multiple sclerosis, preterm birth, poor cognitive function. Perhaps the strongest evidence of Vitamin D efficacy against disease concerns upper respiratory infections - i.e., cold and flu.

Vitamin D can cut upper respiratory infections in half

*Vitamin D supplementation to prevent acute respiratory tract infections: systematic review and meta-analysis of individual participant data*  
(British Medical Journal, 15 Feb 2017)

This meta study (i.e., a study of studies) was from almost 3 years before the covid-19 pandemic. While the most dire scenarios of ICU and ventilator shortages never materialized, that wasn't known as the country swung into action and lockdowns. Just halving seasonal flu hospitalizations would have largely addressed the eventual shortages in ICU capacity that did eventually appear in New York.

No sign of covid-19 governmental competence, as cases tick upwards

The SSRN preprint with Indonesian data was published April 30, 2020. This was well after the covid-19 pandemic strongly hit the United States. There has been more than enough time for 'signs of intelligent life' to fall through the cracks of state and federal incompetence, even if belatedly. However, as of 6/26/2020, even with cases ticking upwards, the story is the same.

So, more people will die, needlessly. More economic destruction will occur, needlessly. **Perhaps the worst aspect of this #GovernmentIncompetence is that there may be a second wave of covid-19 - one that may be worse than the first wave. If there are further lockdowns, small businesses, in particular, will fail at catastrophic rates.**

## **I thereby call for citizens to self-organize a Civic Competence movement.**

And I call on leaders to especially come from the ranks of small businesses and religious communities, whose businesses and communities have been shown to be of little concern to some of our political leaders. For many small business people, the covid-19 crisis is an existential threat both to their livelihoods, but also to their dreams.

### **Such a movement should work at two levels.**

**1** **At a local and personal-network level, such a movement would generally ignore politics and politicians,** and relentlessly spread the word about Vitamin D, vitamin D blood testing, the superiority of sunshine over supplements for raising vitamin D blood levels, and the critical role of Vitamin D in building up the level of immune system robustness in the populace. This aspect of the movement can then later branch into other natural and "alternative" healing modalities that have been suppressed by governmental and medical authorities, and also "heighten the contradictions" between said suppression and what should be the default operation of a civically competent government. This would be a grassroots, bottom up educational process, first and foremost.

**2** **However, equally important, though of less immediate concern, is to take over the 2 stooges of the ruling plutocracy in the United States. These are the Democratic and Republican parties,** which are both equally guilty in selling out the public. This means the public will have to engage in the messy world of Democratic and Republican politics, while keeping themselves pure from corrupting influence and alliances, and any sort of unethical compromises. To avoid wasting time and energy, the public will have to become knowledgeable about the need to install primary candidates, as 86% of House congressional seats are not competitive, with respect to party. In other words, it is certain that either a Democrat or Republican will win a given seat, in 86% of elections, depending on the district. **Getting involved with electoral politics, after party standard-bearers are selected, is too late.**

It is delusional to think that the United States has anything close to a properly functioning democracy. It was shown, statistically, in *Testing Theories of American Politics: Elites, Interest Groups, and Average Citizens*, by researchers Gilens and Page, that the United States' government functions as a plutocracy. [2] To claw back power from the de facto ruling class will not be easy, but can be done. Represent.us has endorsed research showing that "when 3.5% of a population actively engages in fighting for change, they win, every single time". [3] (Note: while I respect represent.us's strategy of getting anti-corruption laws passed at state and local levels, I disagree with not making direct electoral threats at the federal level, right from the get-go.)
